

Announcement Prospectus update

The Board of VanEck Vectors™ ETFs N.V., an investment company with variable capital, having its registered office at Barbara Strozziilaan 310, 1083 HN Amsterdam, company number 34314095 (the **Company** or the **Fund**), hereby informs its investors of the changes to the prospectus of the Fund and its sub-funds (each a **Sub-fund**):

- VanEck Vectors™ AEX UCITS ETF;
- VanEck Vectors™ AMX UCITS ETF;
- VanEck Vectors™ Multi-Asset Conservative Allocation UCITS ETF;
- VanEck Vectors™ Multi-Asset Balanced Allocation UCITS ETF;
- VanEck Vectors™ Multi-Asset Growth Allocation UCITS ETF;
- VanEck Vectors™ Global Real Estate UCITS ETF;
- VanEck Vectors™ iBoxx EUR Corporates UCITS ETF;
- VanEck Vectors™ iBoxx EUR Sovereign Diversified 1-10 UCITS ETF;
- VanEck Vectors™ iBoxx EUR Sovereign Capped AAA-AA 1-5 UCITS ETF;
- VanEck Vectors™ Sustainable World Equal Weight UCITS ETF;
- VanEck Vectors™ European Equal Weight UCITS ETF;
- VanEck Vectors™ Morningstar North America Equal Weight UCITS ETF;
- VanEck Vectors™ Morningstar Developed Markets Dividend Leaders UCITS ETF.

The changes to the prospectus will take effect on 16 February 2022, or on such later date as indicated below. The amended prospectus will be available as per **16 February 2022** on the website of VanEck: www.vaneck.com.

The amendments to the terms and the prospectus affect the investment policy of certain Sub-funds and/or increase the liabilities of their participants, the participants in the following Sub-funds are therefore entitled to redeem their shares in accordance with the existing terms in the prospectus until the 16 February 2022:

- VanEck Vectors™ Multi-Asset Balanced Allocation UCITS ETF;
- VanEck Vectors™ Multi-Asset Growth Allocation UCITS ETF;
- VanEck Vectors™ iBoxx EUR Corporates UCITS ETF.

Explanation to the prospectus amendments

The amendments are a result of the periodic review and update of the prospectus of the Fund. Accordingly, the following changes are included in the prospectus:

- In connection with application of Regulation (EU) 2019/2088 (SFDR), the text in the section “*Sustainability Information*” in the Supplement of each Sub-fund is updated;
- In connection with Regulation (EU) 2020/852 (Taxonomy regulation), the following text is added to the Supplement of each Sub-fund: “*The underlying investments of the Sub-fund do not take into account the EU criteria for environmentally sustainable economic activities.*”;
- The reporting activities of Solution Netherlands B.V. is updated to reflect the current activities of this service provider in connection with the reporting obligations of the Fund;
- In connection with Section 2, Article 8 of the German Investment Tax Act (*Investmentsteuergesetz*) an investment restriction is included in the following Sub-funds:
 - o VanEck Vectors™ Multi-Asset Balanced Allocation UCITS ETF;
 - o VanEck Vectors™ Multi-Asset Growth Allocation UCITS ETF;
- Update of notification method to investors regarding amendment of the prospectus;

- The Sub-fund VanEck Vectors™ Morningstar North America Equal Weight UCITS ETF will be liquidated and therefore no longer be offered as of 17 January 2022. Consequently, Supplement M of this Sub-fund is removed from the prospectus. Investors of this Sub-fund have already been informed separately on this matter;
- Furthermore, the Extraordinary General Meeting of Shareholders of the Company, held on 23 December 2021, approved the change of the name of the Company and amendment of its articles of association. Additionally, the Board has decided to change the names of the individual Sub-funds. The amended change of name is reflected in the tables below:
