**Fund Description**

VanEck Durable High Dividend ETF (DURA<sup>®</sup>) seeks to replicate as closely as possible, before fees and expenses, the price and yield performance of the Morningstar<sup>®</sup> US Dividend Valuation Index<sup>SM</sup> (MSUSDVTU), which is intended to track the overall performance of high dividend yielding U.S. companies with strong financial health and attractive valuations according to Morningstar.

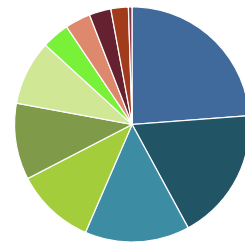
